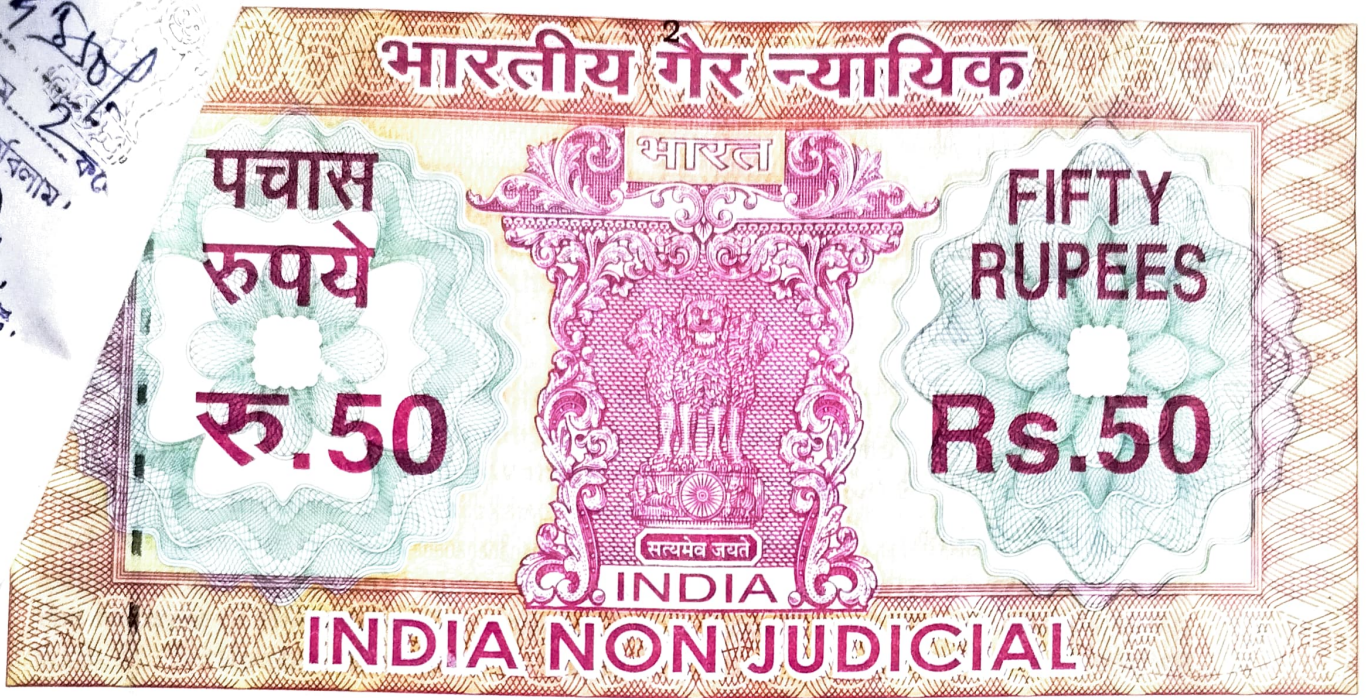

WHEREAS the settlor is desirous of establishing in perpetuity a fund amounting Rs. 10,000/- in India for charitable purpose including relief to the poor, education, cloths and advancement of any other object of general public utility. Not involving or carrying on of any activity for-profit all-over India and for this he is desirous of setting up a Public Charitable Trust for the advancement of the said object in India and whereas the Trustees as above, at the request of the settlor, have given their consent to act as the trustees along with the Settlor for administration of the affairs of the said Trust in accordance with the terms and the conditions hereafter provided.

WHEREAS The Settlor, hereby conveys, transfers, and assigns to the Trustees the above referred sum of Rs. 10,000/- (Ten Thousand Rupees) only as corpus to the Trust, the receipt of which, the Trustees do hereby admit and acknowledge, The Settlor of the **TRUST** hereby conveys, transfers assigns to the **TRUSTEES** the aforesaid funds as mention in the schedule hereunder of the Not any immovable and or movable properties as of now and allows the trustees to have and to hold the same in trust as corpus or the trust, to be used by the trustee to carry out and fulfill the objects of the trust set forth here in and the settlor of the trust hereby relinquishes for all time any claim to or interest in the said assets or fund forming the subjects matter of the trusts.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS: -

Name of the trust shall be: - **SALIM NOOR ACADEMY.**

The Registered Head office of the Trust shall be situated at **Village -Ramnagar, Post Office - Dakshin Ramnagar, Police Station - Baruipur, District - South 24 Parganas, Pin Code - 783387, West Bengal, India.** The office of the Trust may be opened to any other place in West Bengal or to any other of India or open local office or offices at Places deemed necessary. **This place shall be used for corresponding address only and shall not be treated and used as Trust Property.**

1. INTERPRETATION: -

Trust means the Trust created by this Deed - **SALIM NOOR ACADEMY, A non-profitable, non-commercial, non-political PUBLIC CHARITABLE PURPOSE ONLY.**

- a. The Board shall mean the Board of the members which may be filled up by co-option of the existing Trustees created by this Deed with renowned and suitable persons.
- b. **TRUST PROPERTY:** -shall include every kind of property movable and immovable to be owned by the Trust and mentioned in accounts, books and other documents in the possession, custody and control or that ought to be in possession, custody and control or possession of the Trust.

2. MAIN OBJECTIVES OF THE TRUST: -

- i. **Education** - Encouraging children's interest in education is pivotal. By cultivating a sense of curiosity and making learning engaging, we aim to provide children with not just education but a passion for learning. Ensuring access to quality education is essential in shaping their future.
- ii. **Rural Development** - Uplifting the lifestyle of rural communities is a fundamental aspect of development. By implementing programs focused on improving infrastructure, education, and creating employment opportunities, we can positively impact the lives of those living in rural areas.
- iii. **Social Welfare and Development** - - To promote the welfare and development of underprivileged sections of society by providing resources, education, and assistance.
- iv. **Healthcare Services** - To organize health camps, provide medical assistance, and promote public health awareness among communities.
- v. **Environment Conservation** - - To work on environmental conservation projects, including tree planting, waste management, and promoting sustainable practices.
- vi. **Women and Child Welfare** - To support programs focused on women and children's health, education, and safety.
- vii. **Youth Empowerment** - Empowering the youth to be self-reliant is essential for their growth and the nation's progress. Providing access to skill development, mentorship, and resources will enable them to contribute effectively to society and achieve personal success.
- viii. **Relief of the poor** - To give financial or other assistance in kind by way of distribution of books, notebooks, cloths, uniforms, or meals for the poor and indigent and to the persons suffer due to natural calamities.
- ix. **Old age home** - To provide these elders with the care, respect, and love they deserve, ensuring they can spend their last days in peace and comfort.
- x. **Orphanage** - To provide care and education to children who are orphaned or abandoned, and to help them develop into responsible adults.
- xi. **Other objects of general public utility** -
 - a) To acquire property for the sole use of the public by making it available for public purposes, for example - a library, clinic, crèche or a community

hall to be available for public use as training classes, seminars, discourses and other public functions for benefit of the community in general.

- b) To promote, establish, start, maintain, organize, run, and manage helping common people to get benefits of various government schemes.
- c) To promote, establish, start, maintain, organize, run, and manage Educating women and unemployed youths in various handicrafts, vocational education, computer and technical education for self-reliance and providing certificates.
- d) To Providing food, clothing and shelter to the needy by constructing temples, ashrams, hospices etc.
- e) To establish, start, maintain, organize, run, manage, protect the environment by planting trees, raising environmental awareness, cleaning garbage and arranging toilets.
- f) To establish, maintain and run Schools, Colleges, Social service centers, Industrial Training center.
- g) To establish, Training Centre, and allied education institutions.
- h) To establish, Cultural, and Social Institutions.
- i) To spread for promotion of education and learning in all branches more specifically in Science and Technology.
- j) To advance Indian Culture and Literature, Service of this Country for the benefit of our Nation.
- k) To train teachers and workers in ideals and practice of the true spirit of the education and learning.
- l) To establish research and training centers for the furtherance of education/learning in its various fields and branches.
- m) To undertake propaganda, training and education of the masses either of its own or in co-operation with similar Agencies working for the cause of all round development of the Society.
- n) To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- o) To acquire and maintain the movables and immovable properties for achieving and said objects.
- p) To promote, establish, start, maintain, organize, run, and manage blood donation camp.
- q) To confer title on eminent personality in the field of science, education, literature, etc.,

- r) To establish the colleges to impart education in the area of higher education especially the emerging field like, Electronics, Bio-technology, and other allied fields.
- s) To establish, develop, maintain, run and to do all kinds of Educational Programs, take part in state Govt. and central Govt. programs like NSDC (national skill Development Corporation), NCVT, PBSSD & any other educational programs.
- t) To start, support, organize and give financial aid to the social, cultural and moral renaissance of the people and to develop physical, mental and educational capacity of the society and to promote schemes for such purposes.
- u) To promote the educational, social; Economic, and welfare of the people in general and under privileged and back ward section of the society in particulars.
- v) To organize, manage, maintain and run Education Movement, Social and Education Caravan, Computer centre, Work-shop, Incentive training programme, Training Programmes, Symposia Seminars, Meetings and such other programmes for the promotion of education and literacy among the people in general and backward section of the society in particular.
- w) To award scholarship to deserving students for technical, medical, professional, religious, general and higher studies and also to provide financial help; to deserving students and scholars.
- x) To encourage athletic activities of youth and student and to conduct tournaments, sports and game for them.
- y) The trust will receive donations from the public which can be in the form of money and materials, as well as movable and immovable property. All donation any person or any organization by way of valid instrument and must be attached as per proper legal norms and valid document and receipts.
- z) To raise funds or receive all sorts of grants, aids, donations or any other financial assistances from the Govt. of India, Govt. of West Bengal in the Ministry of Health, Education and Library Sciences etc. and also from the Ministry of Social Welfare and any other Social Welfare Govt. Institutions and also from any individuals, which may be essential mainly for the development of this Society only, and also to utilize all those collections, donations, funds solely for this society.
- aa) To ensure child's or children's education to the children of the down trodden especially people of the all communities and to help the poor.

- bb) To organize, hold and/or arrange to hold seminar, function, workshops, conferences, lectures, debates, recitations, symposiums and other cultural and literary programmes and social gatherings by inviting men of eminence and scholars of outstanding national reputation for the same for the promotion of the aforesaid objects of the TRUST.
 - cc) To seek receive and take any subscription or gifts or donation of all kinds like money or property both movable or immovable donated by any organization or individual in INDIA for any of the objects of the TRUST
 - dd) To organize creche, vocational homes, residential schools and other Government programmes, extending schemes as the TRUST BOARD may deem fit and proper.
 - i) To raise fund by way of donations, fees etc. from any person/s, the state or central Government Organizations, companies corporate agencies, institutions or otherwise for the TRUST and/or to provide funds to such beneficiaries as many be identified by the TRUST: All donation any person or any organization by way of valid instrument and must be attached as per proper legal norms and valid document and receipt
 - ii) To undertake any other activity incidental to the above activities but which are not inconsistent with the above objects.
2. **This Trust shall be commenced on and from 1st Day of December, 2025.**
The Settler and Trustee not the owner of the Trust property they are only custodian of the property they cannot claim any property as his/their own property.
 3. The trust shall never borrow and/or augment money from the public or open market by announcing attractive financial investment scheme.
 4. **All aims/objects/purpose of the trust herein stated above shall come into effect/force after necessary appointment of the competent govt. authority in the case where affiliation/permission/license/ sanction is required.**
 5. **The trust will never acts like Micro financing, micro credit, franchise and Money Laundering (act-2012) Economic offence/crime and in nature and shall not obtain any donation or like that from abroad without getting the permission of FCRA ACT from the central Govt./the competent Govt. authority which the Trust and the trustees are responsible for and the whole trust is void. And come under the all punishable laws.**
 6. **The Trust will never acts which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country for which the trust and the trustees are responsible for that and the whole trust is void. and come under the all punishable law.**
 7. **The Settlor and the Trustees can not claim any ownership right title and interest upon the trust property and future trust property.**

At present the trust has no immoveable and landed property in its own name and no immoveable and landed property is being settled in favour of this trust by this document and no immoveable property is involved in this trust deed.

9. **AMENDMENTS TO THE SCHEME:** If any time it is found that alterations in any of the provision of the Trust or scheme for the purpose of effective achievement of the object of the Trust are imperative and very essential, then the Board shall approve such alteration by a resolution passed in its meeting and thereafter the modification shall become part and parcel of the terms, condition and provisions of this Trust and of this scheme.

The Board may at any time and from time to time make, amend, delete and rescind rules and bylaws for the conduct of this business, for the control, management and administration of the Trust made under this Trust deed and for carrying out the objects of the Trust relating to any matter under this scheme, provided that such rules and bylaws shall not be inconsistent with or repugnant to any provisions of the scheme of the Trust.

10. DELEGATION OF POWER:-

The Trustee shall have the power to delegate the administration of the Trust to Any third party which he in his absolute discretion shall see fit provided always That the Trustee remains responsible for the actions of any party to whom he Has delegated authority.

11. APPOINTMENT OF NEW TRUSTEES:-

It is agreed that if the Trustee sees fit he may appoint an additional Trustee to Be Trustee of the Trust. Change of Trustee, It is agreed that if the Trustee becomes unable or unwilling to act as Trustee of the Trust he or his lawful representative may appoint a new Trustee to be Trustee of the Trust provided that this new trustee shall accept his appointment.

12. BENEFICIARIES OF THE TRUST:-

The Trust is established for the Educational and cloths to Citizens of India and the class of people mentioned above without discrimination of caste, religion, race/creed or sex.

13. REMUNERATIONS:-

The trustees are all forming the instant Trust as an obligation to wards the society at large and for such upright action will augment the joy and happiness amongst the trustees and they will not be remunerated personally for their attachment with the Trust remuneration clause will attract the Income Tax Act of India.

- i) To perform that notwithstanding herein contained in the income as the corpus OF THE TRUST fund the same shall be applicable and applied to for PUBLIC CHARITABLE PURPOSE ONLY within such territories

- and subject to such conditions or limitation if any as may from time to time be laid down by the Income Tax Act, 1961 or any other acts governing taxation of income the wealth of PUBLIC CHARITABLE TRUST so as to render the TRUST hereby established as well as its income eligible for exemption from taxation under such Act or acts, now or prevailing or any modification replacement thereof.
- ii) To act in such a way that the TRUST hereby established shall always retain the status of one such TRUST to which provisions of section 80G/ 12A/ 35AC/FCRA 10(23C) IV/V/VIA of the Income Tax Act, 1961 or any modification replacement or thereof for the time being in force shall apply so that any donation or contribution thereto is recognized as eligible for exemption or relief from tax in the hands of the donor.

14. ADMINISTRATION: -

The properties and funds shall vest in the name of Trustees constituted by persons executing the Deed of the Trust. The number of members of Board of Trustees shall not exceed 15 and the vacancies can be filled by co-option by the existing Trustees.

15. OFFICE BEARERS: -

Office bearers of the trust shall be initially as follows: -

The Board of Trustees is also Empowered to create any office bearer post and elect office bearers to fill up the post for the Trustees and/or from outside the Board of Trustees. The above office-bearers shall be elected by the co-option of the Trustee at a meeting convened for the purpose.

16. VACANCIES: -

A vacancy shall arise among the Trustees in the following cases-

- When a Trustee dies.
- When he resigns his office as a Trustee.
- If he becomes Bankrupt.
- If he becomes insane or otherwise become incapable to act or
- When he is absent from three consecutive meeting of the Board, unless the Board records condoning such absence in the minutes of the meetings of the Board of Trustees for substantial cause.
- When it becomes insolvent.
- When convicted of any criminal offence involving moral Turpitude.

- When he acts or does anything detrimental to the interest of the Trust.
- / On medical evidence when he is declared physically or mentally unfit by a of the Board at a meeting convened for the purpose.

7. FUNCTIONS OF THE OFFICE:-

A. President

- a) The president is empowered to take decisions on urgent matters, but such be Approved by the Board within a period of 30 days.
- b) The President will preside over the meeting of the Trust and conduct the proceedings.
- c) The president in his own decision or by the request of the $\frac{3}{4}$ of existing members can call for the meeting of the Trustees.
- d) The President is empowered to delegate such powers to any other members of the Trust as he may deem fit.
- e) The President is empowered to dissolve the committee or the Board in any abnormal Situation.

B. Secretary

The Secretary who will act as managing trustee of the Board of Trust, elected under the control and supervision of the Board, shall conduct and manage all the affairs of the Trust, it's all properties and institutions, sign papers and carry on the despondence on behalf of the Trust, and shall be responsible for the safe custody of records of the Trust, and keeping of the proper accounts thereof. He shall also perform such other duties as may be entrusted to him from time to time. The President, The Secretary shall attend to the correspondence and today affairs of the Trust. The Secretary shall carry out all the resolution of the Trust and for that purpose he shall have power to incur necessary expenditure form and cut of the funds of the Trust, subject to a maximum of Rs. 50,000/- (Rupees Fifty Thousand) only and anything above amount Rs.50, 000/- (Rupees Fifty Thousand) is to be incurred with the sanction of the Board. He shall have the custody of the correspondence and other books relating to the affairs of the Trust.

C. Treasurer

The Treasurer shall conduct and receive all sorts of subscriptions, donations and deposit or money and grant receipts of money thereof. He will maintain and keep cash book and such other books of accounts as are necessary.

18. APPOINTMENT OF THEIR EMPLOYEES:-

They shall have also power employ necessary staff for management, administration and Running of the Trust in general and of institution in particular on such reasonable salaries and remunerations and on such terms as may be appear proper, to the Trustees for Managing the affairs of the Trust and the Institutions and for the purpose of achieving of the Objects of the Trust. They may be allotted or entrusted with such duties and responsibilities.

BANK ACCOUNT:-

- a) The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of **SALIM NOOR ACADEMY** such accounts shall be single or jointly operated by the Settlor only or with the president/secretary/Treasurer or as shall be decided mutually in meeting of the **TRUSTEE BOARD**
- b) The Trust may open Bank Account/s in the name of institution/organization founded by the Trust
- c) That the Settlor singly can operate the Bank Account.

20. POWER OF THE SETTLOR

- a) The Settlor will hold his designation for the lifetime and after demise of the settler his legal heirs or successors can hold the same designation if he is neglect then the Board of trustee can decide and appoint another Trustee as settler.
- b) The Settlor only or with the board of trustees can decide to run and fulfill objectives of the Trust.
- c) The Settlor only have power to remove any trustees from the trust board if found any guilty.
- d) The Settlor only has power to remove, appoint, updation, modification or amendment of the trust deed.

21. THAT the TRUSTEES may engage themselves and carry on any business for and on behalf of the **TRUST** established by this Deed and may invest any part of funds or assets of the **TRUST** fund in such business or Businesses for the benefit of the beneficiaries and in such case individually that **TRUSTEE** shall remain responsible for his wrong and loss and for this the **TRUST MANAGING TRUSTEE** and the **SETTLOR** shall remain indemnified:

22. THAT the TRUSTEES shall maintain the true and fair account of the **TRUST FUNDS**, receipts and disposed of or spent and all matters in course of management of this **TRUST**, in respect thereof or in relation to the carrying out of the object and effects to the **TRUST PROPERTY**. The accounting year of the **TRUST** shall be accounted for i.e. from 1 April to 31 March, of each English calendar year.

23. THAT the TRUSTEES shall have the full power to compromise or to compound all actions against such suits and settle all accounts relating to the **TRUST PROPERTY** and to do all suits and settle all accounts relating as fully and

effectually as if they were absolutely entitled to the TRUST PROPERTY without being liable or answerable for any loss thereby.

4. **THAT** the receipt of the **TRUST** for any money, stocks, funds, shares, securities or Investments paid delivered or transferred to them in execution of the TRUST or power Hereof shall effectually be released and discharged the persons paying delivering or Transferring the same.
25. **THAT** the **TRUSTEES** jointly shall be responsible for such money, stocks, shares, funds and securities as they actually receive notwithstanding their respectively signing a receipt jointly with other for the sake of conformity and shall be answerable and accountable for the account, receipts neglects and any banker, broker or other person or persons with whom or whose hands any TRUST moneys or securities may come or be deposited or given or for insufficiency of deficiency of any stocks, shares, funds or other securities nor for any other loss unless the same shall happen through their default or negligence respectively:
26. **THAT** the **TRUSTEES** shall reimburse and pay and discharge out of the TRUST FUND all expenses incurred in course of the execution and administration of the TRUSTEES and in uses or for carrying out their duties these presents but they shall not be Entitled to any honorarium or salary for the TRUST:
27. **THAT** in case of difference of opinion among the **TRUSTEES** decision of the majority **TRUSTEE** as the case may be shall prevail and by every three months meeting of the **BOARD OF TRUSTEE** shall be held and evolution of the works of each member of the **BOARD OF TRUSTEE** shall be made in the annual meeting of the **BOARD** and in that meeting ineffective member of the **BOARD** shall be expelled in proper system:
28. **THAT** any **TRUSTEE** may delegate in writing all or any of his or her powers under these presents to his or her **CO-TRUSTEE** as nominee who will be entitled to exercise such power or powers. In the same manner as the **TRUSTEE** himself could do personally notwithstanding anything herein contained the **TRUSTEE** shall be entitled to use the name of the TRUST in connection with any matter relating to the said TRUST and for the purposes the said **MANAGING TRUSTEE** for the TRUST shall appoint, dismiss and reappoint any staff, manager, lawyer, adviser, advocate, auditor and substitutes and pay their expenses and fees as shall be deemed reasonable from time to time and for the purposes of the said

matters and actions in Courts or otherwise the TRUSTEES or any of them or the MANAGING TRUSTEE shall be entitled to sign and verify all complaints, petitions, pleadings, written statements memorandums, Vakalatnamas powers the the TRUSTEES or any of them shall be entitled to appear for and on behalf of the TRUST and give evidence orally or adduce any evidence and take necessary proceedings on the matters and actions:

29. TRUSTEES or any of them shall be entitled to appear for and on behalf of the TRUST and give evidence orally or adduce any evidence and take necessary proceedings on the matters and actions:
30. THAT any of the TRUSTEES may retire from trusteeship if he or she so desires, but with acceptable reasons:
31. THAT the power to appoint/nominate new or additional TRUSTEES so as not to exceed the maximum number of TRUSTEES existing herein and to fill vacancy in the office of the TRUSTEE shall vest in the continuing TRUSTEE or TRUSTEES.
32. THAT on a new TRUSTEE being appointed/nominated on his signing the Minute Book to holding the effect of his possession of the TRUST PROPERTIES shall vest in him along with the other TRUSTEES for the time being and he will be entitled or to carry out the duties and function of a TRUSTEE.
33. THAT for amendment or change of any clause of this TRUST DEED the MANAGING TRUSTEE shall prepare it and get in accepted by the BOARD OF TRUSTEE: THAT in case members of BOARD OF TRUSTEE decide finally in the meeting of the BOARD OF TRUSTEE that they shall not continue the TRUST may more, they shall after clearing all the accounted liabilities fully of the TRUST from the proceeds of the assets of the TRUST, wind up THE TRUST legally, and shall handover all the residue assets of the TRUST to a similar CHARITABLE TRUST or The Government who will carry on all the works of this TRUST.
34. THAT in all meetings of the TRUSTEES 3/4th of the existing TRUSTEES will form a quorum provided however, that if it the number of TRUSTEES fall below 3/4th then for the purpose of appointing a TRUSTEE 3/4 of the existing TRUSTEE will be a quorum.

IMMOVABLE PROPERTIES OF THE TRUST: -

no immovable property belongs to the Trust shall be sold, exchanged, transferred, converted, mortgaged or alienated in any manner whatsoever except when such exchange, transfer, conversion or alienation:

- a) Is imperative in the interest of the Trust and Institutions and Department connected therewith,
- b) Is not likely to adversely affect to any extent whatsoever the existence and benefit of the Trust, Institution and departments connected therewith and object of the Trust, and
- c) Is decided to that effect by the Board in its meeting by a resolution passed by majority of the Trustees present.

36. POWER TO ALTER RULES AND REGULATIONS: -

The Board of Trustees shall have full power and authority to make, alter and rescind rules and regulations for the management and administration of the Trust. Any amendment to the Trust Deed will be carried out only with the approval of the Commissioner of Income Tax.

37. ACCOUNTS & AUDIT: -

- a) The Trustees shall maintain true and correct accounts of all Trust monies and of all the income and investments and all the outgoing expenses.

- ii) The Board shall also determine from time to time, the amount it shall spend on the various activities of the Trust.

APPLICABILITY OF TRUST ACT:-

The provisions of the Indian Trust Act 1882 shall apply to all matters not specifically mentioned in these presents.

41. AREA OF OPERATION:-

That all activities of the Trust shall be extended to the territories of India.

42. IRREVOCABLE:-

That the Trust is irrevocable

43. UTILISATION:-

To apply the whole or part of the income of the Trust or accumulation thereof or whole part of the corpus of the Trust Fund for one or more of the object of the Trust may determine from time to time.

44. SAVE CUSTODY OF TRUST ESTATE:-

That all securities, investments bonds, title deeds etc. relating to the Trust estate shall be kept in the safe custody with the Trustees or Bankers(s) of the Trust.

45. DECLARATION:-

This Trust and Scheme set forth under Indenture shall come into force immediately after the execution and registration thereof. The Settlor and Trustees above named also hereby declare that they have consented to be the Trustee under this Trust and that in witnesses whereof the Settlor, Trustees above named as party hereto have affixed their signature hereunder.

SCHEDULE

LAWFUL PURPOSE A trust may be created for any lawful purpose. The purpose of a trust is lawful unless it is (a) forbidden by law, or (b) is of such a nature that, if permitted, it would defeat the provisions of any law, or (c) is fraudulent, or (d) involves or implies injury to the person or property of another, or (e) the court regards it is immoral or opposed to public policy. Every Trust of which the purpose is unlawful is void. And where a trust is created for two purposes, of which one is lawful, and the other unlawful and the two purposes cannot be separated, the whole trust is void.
